## 2024-25 Budget

Faced with a \$1.45 million decline in funding and rising costs, the Aspen View Public Schools Board of Trustees approved what Chair Candyce Nikipelo describes as a 'difficult' 2024-25 budget, which includes a deficit of almost \$500,000 and significant cuts to expenditures, including staffing reductions.

Aspen View's total budgeted revenue for 2024-25 is approximately \$43.7 million, which is almost \$1.45 million less than was budgeted in 2023-24. Provincial funding, which is Aspen View's largest revenue source, has decreased by close to \$970,000; approximately 3 per cent less than was budgeted in 2023-24. Federal funding has decreased by over \$347,000, which represents a 22 per cent drop from the 2023-24 budget.

A significant portion of the drop in funding is tied to declining enrolment; Aspen View's projected enrolment for 2024-25 is 2,596 students, 29 students less than the 2023-24 enrolment of 2,625.

Aspen View's revenue is also negatively impacted by changes to provincial funding. Funding for socio-economic factors has dropped by 22 per cent, or over \$232,000. Stabilization funding, intended to mitigate the impact of declined enrolment, has been cut by 34 per cent, or over \$197,000.

In addition to declining revenue, Aspen View is also experiencing significant cost escalations due to inflation, including salary grid increases, employee benefit costs, contract costs, and higher costs for repairs and maintenance, supplies, utilities and insurance.

To offset both the decline in revenue and the inflationary cost increases, Aspen View has reduced budgeted expenses by almost \$1.3 million, to \$44.2 million, which is approximately 3 per cent less than was budgeted in 2023-24.

Over \$1.27 million of the spending decrease will be realized through staffing reductions, while increased costs for services, contracts and supplies will be mitigated through planned expenditure reductions in non-school budgets. Instruction spending, which received a \$1.37 million increase in 2023-24, has been reduced by \$1.57 million in 2024-25.

The budgeted deficit of \$499,475 will be funded from operating reserves, which are projected to be at just under \$2.5 million at the end of 2024-25.

### 2024-27 Education Plan

Katherine Mann, Associate Superintendent of Curriculum & Technology, presented Aspen View Public Schools' 2024-27 Education Plan, which the Board of Trustees unanimously approved for submission to Alberta Education.

The 2024-27 Education Plan maintains Aspen View Public Schools' three division priorities of Student Success & Completion, Wellness, and Engagement. Within each priority are target outcomes, strategies and performance measures that indicate to stakeholders how progress towards these objectives will be evaluated.

Associate Superintendent Mann highlighted a new target outcome to employ quality assessment practices to achieve high levels of student success.

### Athabasca University Lease

• Superintendent Constantine Kastrinos updated the Board of Trustees that Aspen View Public Schools signed a five-year lease agreement, effective July 1, 2024, which will see Aspen View's division office relocated to the Athabasca University campus, opening the doors for even greater collaboration between the two institutions.
